

**EVALUATION COMMITTEE MINUTES – No. 5****PUBLIC NOTICE FOR THE SELECTION OF 9 EXPERTS IN SUPPORT OF CO-DESIGN PROCESSES WITHIN THE FRAMEWORK OF THE PROJECT “EMPOWERING NEW ENERGIES AND RESOURCES IN GREECE ITALY AREA” (ACRONYM ENERGIE), FINANCED BY THE INTERREG GREECE–ITALY PROGRAMME 2021/2027**

On 15 July 2026, at 02:00 p.m. (CEST), the Evaluation Committee (hereinafter also referred to as the "Committee") convened online via the Google Meet platform to carry out the evaluation activities related to the selection procedure referred to in the above-mentioned Public Notice.

The Evaluation Committee convened to proceed with the assessment of the applications submitted by the eligible candidates for **Profile C - TALENTS FOR ECONOMIC DEVELOPMENT, BUSINESS MODELS AND FINANCE FOR REGENERATION**, as referred to in Article 2 of the Public Notice.

The Committee recalled the assessment criteria set out in Article 5 of the Public Notice. It then proceeded with the assessment of the applications submitted by the eligible candidates for Profile C, in the order of receipt, awarding scores to each application in accordance with the criteria set out in Article 5 of the Public Notice.

Upon completion of the assessment of all applications submitted for Profile C, the Evaluation Committee compiled the list of candidates and the corresponding scores awarded, as summarized in the table below:
