

**EVALUATION COMMITTEE MINUTES – No. 10****PUBLIC NOTICE FOR THE SELECTION OF 9 EXPERTS IN SUPPORT OF CO-DESIGN PROCESSES WITHIN THE FRAMEWORK OF THE PROJECT “EMPOWERING NEW ENERGIES AND RESOURCES IN GREECE ITALY AREA” (ACRONYM ENERGIE), FINANCED BY THE INTERREG GREECE–ITALY PROGRAMME 2021/2027**

On 04 August 2026, at 09:15 a.m. (CEST), the Evaluation Committee (hereinafter also referred to as the "Committee") convened online via the Google Meet platform to proceed with the interviews of the candidates admitted to the selection procedure for **PROFILE D - TALENTS FOR PARTICIPATORY DESIGN, TERRITORIAL GOVERNANCE AND CAPACITY BUILDING**, as referred to in Article 2 of the Public Notice.

On 04 August, at 09:30 a.m. (CEST), the Committee commenced, via the Google Meet platform, with the interviews of the candidates admitted for Profile D, in the order set out in the NOTICE OF CONVOCATION TO THE INTERVIEWS.

Candidates are informed of the rules and procedures governing the interview, as specified in the Notice of Convocation to the Interview and the Privacy Notice.

At the beginning of each individual interview, all candidates are required to present a valid identity document for identification purposes.



Upon completion of the interviews of all candidates, the Evaluation Committee drew up the list of candidates and the corresponding interview scores, awarded in accordance with the criteria set out in Article 5 of the Public Notice. The results are set out in the table below.
