



PUBLIC NOTICE FOR THE SELECTION OF 9 EXPERTS IN SUPPORT OF CO-DESIGN PROCESSES WITHIN THE FRAMEWORK OF THE PROJECT “EMPOWERING NEW ENERGIES AND RESOURCES IN GREECE ITALY AREA” (ACRONYM ENERGIE), FINANCED BY THE INTERREG GREECE–ITALY PROGRAMME 2021/2027

NOTICE OF CONVOCACTION TO THE INTERVIEWS

Interview calendar – PROFILES C & D

With reference to the selection procedure referred to above, this Notice constitutes convocation and, to all effects, formal notification for the candidates admitted to the interview stage for:

- PROFILE C) TALENTS FOR ECONOMIC DEVELOPMENT, BUSINESS MODELS AND FINANCE FOR REGENERATION
- PROFILE D) TALENTS FOR PARTICIPATORY DESIGN, TERRITORIAL GOVERNANCE AND CAPACITY BUILDING

In line with the provisions of Article 5 of the Notice, interviews will be conducted in telematic mode, through the online video-conferencing platform [Google Meet], according to the calendar set out in the Section “Interview calendar” below.

To this end, each candidate will receive, no later than **three (3) calendar days** before the interview, an email at the personal email address indicated in the application, specifying the operational arrangements and the link to connect to the platform on the day of the interview.

The processing of personal data relating to the conduct of the interviews is carried out by ARTI in accordance with Regulation (EU) 2016/679 (GDPR) and the applicable national legislation.

The Privacy Notice relating to this stage of the selection procedure is published together with this Notice of Convocation on ARTI's institutional website.

Candidates are invited to read it carefully before participating in the interview.

Candidates convened for interview must have a valid identity document available.

This Notice constitutes formal notification of convocation for all legal purposes. Candidates who fail to attend the interview at the scheduled date and time — regardless of the reason, including force majeure — will be considered to have withdrawn from the selection procedure and will not proceed further in the process.

Technical arrangements and rules for the conduct of the interview

Candidates are invited to equip themselves, for the interview, with a suitable and properly functioning device, fitted with webcam and microphone, and with an internet connection of sufficient quality to support the interview without interruptions.



For the purposes of the regularity of the interview, the following rules apply:

- Identification of the candidate takes place by showing, in front of the webcam, a valid identity document.
- Candidates must join the meeting indicating their first name and surname, so as to be identified and admitted.
- The room from which the candidate connects must be quiet, sufficiently well-lit and such as to allow the candidate to be recognised.
- The candidate must keep camera and microphone on for the entire duration of the interview and keep their gaze directed towards the camera.
- Mobile phones and any other device not used for the connection must be switched off for the entire duration of the interview.
- Interviews are public and are conducted exclusively for the purposes of the ENERGIE selection procedure. **ARTI will not make any audio or video recording of the interviews.** Likewise, candidates, observers and any other participants are **strictly prohibited** from:
 - recording, copying or reproducing, in whole or in part, the interview by any means;
 - making screenshots or screen recordings;
 - using software, applications or external devices capable of recording audio or video;
 - disseminating or publishing images, sounds or information acquired during the interviews through websites, social media, messaging platforms or any other communication channel.

Failure to comply with these rules may result in immediate exclusion from the online session and may give rise to any further liabilities provided for by the applicable legislation.

- The use of instant messaging within the video-conferencing application is prohibited, except to report technical problems.
- Observers admitted to attend the interviews shall:
 - access the meeting using their full name;
 - keep their microphone and camera switched off throughout the session;
 - refrain from interacting with candidates or members of the Evaluation Commission;
 - comply with all instructions given by the Chair of the Evaluation Committee or by ARTI staff responsible for the management of the online session.

Failure to comply with these rules may result in immediate removal from the online meeting.

- ARTI shall not be held responsible for interruptions or malfunctions attributable to the internet connection, hardware or software used by candidates or observers, except where such interruptions are directly attributable to ARTI's technical infrastructure. Where technical issues prevent the regular conduct of the interview, the Evaluation Committee may suspend and resume the interview or reschedule it to another date or time, as recorded in the minutes.



Without prejudice to the participation of the admitted candidates, any person interested in attending the interviews as an observer may submit a request by email to: energie.project@arti.puglia.it no later than **three (3) calendar days** before the scheduled interview.

The request shall include:

- the completed request form made available by ARTI;
- a copy of a valid identity document.

Following verification of the request, ARTI will send the connection link together with the operational instructions for attending the online session.

Participation in the interview implies acceptance of the operational rules contained in this Notice and acknowledgement of the Privacy Notice published by ARTI for this stage of the selection procedure.

The Evaluation Committee reserves the right to adopt any organisational measures necessary to ensure the orderly conduct, transparency and regularity of the interviews.
